

# **NCMDT Enhanced Care Program**

Serving towns throughout North Central Connecticut

### What is the NCMDT Enhanced Care Program?

The North Central Multidisciplinary Team (NCMDT) Enhanced Care Program provides support and services free of charge to children who are victims of a crime that has been reviewed by the NCMDT. The child's family also qualifies to receive these free supports and services. A thorough screening and assessment is provided to the child and to all participating family members to identify any needs and offer appropriate service recommendations. The program is federally-funded through the Office of Victim Services of the Connecticut Judicial Branch.

#### **Available Services**

Individual/Family Therapy, Group Treatment, Education about Victim's Rights, Criminal Justice Process Information, Crisis Intervention, Support Referrals, Consultation, Advocacy, OVS Victim Compensation claims assistance.

## **Trauma-Focused Therapy for Children and Families**

CHR provides therapy services through a variety of evidence-based treatment models including:

- Trauma-Focused Cognitive Behavior Therapy (TF-CBT)
- Child and Family Traumatic Stress Intervention (CFTSI)
- Modular Approach to Therapy for Children (MATCH)
- Attachment, Regulation and Competency (ARC)

## **Service Delivery**

Clinical services are provided at CHR's Enfield and Bloomfield office locations. Other services are provided in-home or in the community based on the family's needs.

#### How to make a referral

Referrals may be made by the Klingberg Children's Advocacy Center or other agencies working with child victims and their families, including the courts and police departments. Families may also contact CHR directly for services by calling 1.877.884.3571 and asking for NCMDT Enhanced Care services.
